CONDITIONS OF ADMISSION

- ✓ **Confirm your enrollment.** A non-refundable **\$200 Advanced Enrollment Deposit** is required to confirm your plans to attend the University and reserve your space in the incoming class. You may submit the Advanced Enrollment Deposit online by logging in to your wolfPAW account (<http://wolfpaw.ncsu.edu>) and following the instructions on the Application Status screen. You may also confirm by returning the form below with your payment by check or money order. Payment must be made by **May 1** for the Fall Semester or Summer Sessions. Students accepted after May 1 should return form and payment within 10 days of receipt of the acceptance letter. The deadline for Spring payment is **December 1** or within 10 days of receipt of the acceptance letter.
- ✓ **Submit official final transcript.** You must submit an official final transcript from all institutions you have attended. Final acceptance is contingent on your maintaining a level of academic performance that is equal to or better than your previous academic record. Your enrollment will be cancelled if your official final transcripts are not received by the following date: June 1 (fall semester domestic transfers); July 15 (fall semester all others); December 20 (spring semester).
- ✓ **Notify this office of changes in your conduct record.** Final acceptance to NC State University is contingent on your maintaining a satisfactory conduct record. You must promptly notify our office in writing of any criminal charge, any disposition of a criminal charge, any school, college, or university disciplinary action against you, or any type of military discharge other than an honorable discharge that occurs at any time before or after you are admitted. Failure to do so will be grounds to withdraw your admission, or to dismiss you after enrollment.
- ✓ **Submit your Immunizations and Medical History.** NC law requires proof of immunizations. You will be required to enter your information online and then send supporting documents. Please follow the "Immunizations & Medical Records" link on the Student Health Center website: <http://healthcenter.ncsu.edu> for instructions. You will not be allowed to attend classes if your immunizations and your medical history are not complete. There is a \$150 re-enrollment fee if your classes are cancelled.
